I'm sure there are many Americans who are breathing a sigh of relief with President Biden's executive order to cut federal student loan debt by up to \$20,000 for the select few who qualify.

The new rules also cap payments based on income levels, eliminate loan interest accrual and **continue** the pause on student loan payments until January 2023.
